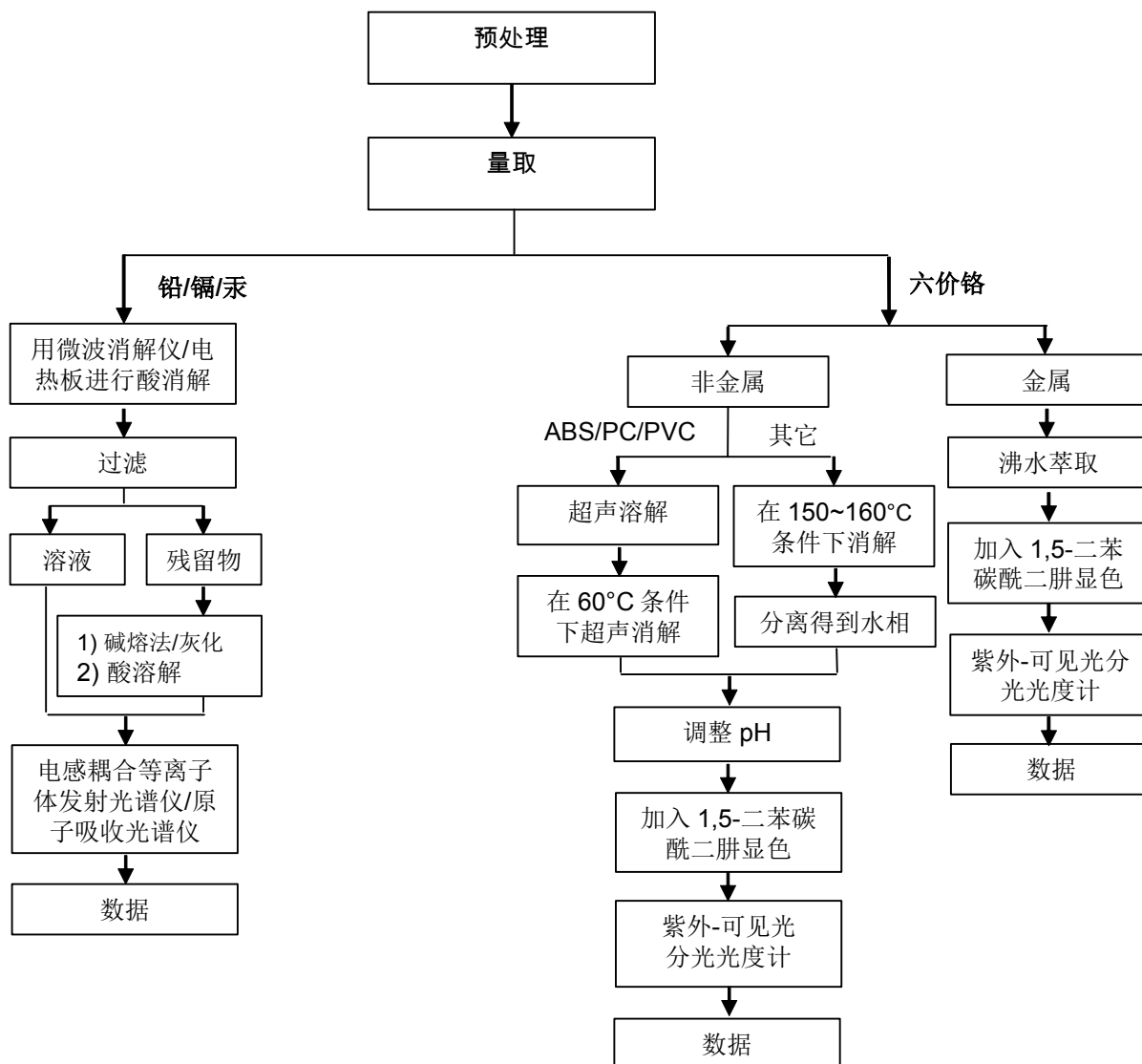

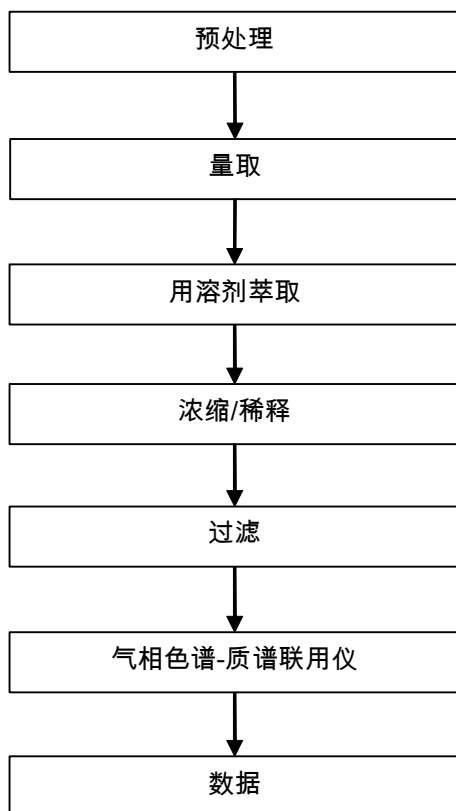
Pb/Cd/Hg/Cr<sup>6+</sup> 测试流程图

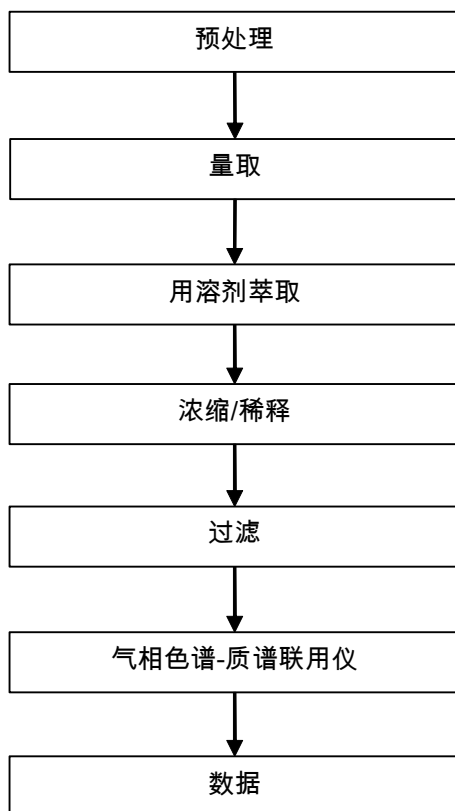
